I further understand and accept that the ski boot binding system, which I may have rented from the ski area and/or rental shop, will not release at all times nor under all circumstances, nor is it possible to predict every situation in which it will release and it is, therefore, no guarantee of my safety and is not to be considered a safety device. I, therefore, release the rental shop, its employees, agents, servants, and the ski area and its facilities owners, agents and employees from any and all liability for damage and injury to myself or to any other person or property resulting from the use of such equipment accepting full responsibility from any and all such damage or injury of any kind which may result.

I, the undersigned, have read and understood the terms of the above season pass release from liability and I am signing it freely and of my own accord realizing that it is binding to myself, my heirs or assigns. If my signature appears here below on behalf of any minor entrusted to my care or related to me. I hereby agree to indemnify and hold harmless the ski facility, its agents, employees, servants, officers, directors and shareholders from any and all claims, expense, costs, damages and the like including reasonable attorney fees as a result of the minor engaging in any ski and/or snowboarding related activity, rental of equipment and/or ski instruction at the facility.
